Reference: (1) Robert C. Pierson (NRC) letter to Robert H. Ihde (DCS) dated April 30, 2002, *Draft Safety Evaluation Report on Construction of Proposed Mixed Oxide Fuel Fabrication Facility*

Duke Cogema Stone & Webster (DCS) is scheduled to deliver on 31 October 2002 a supplement to the Construction Authorization Request for a Mixed Oxide Fuel Fabrication Facility. In preparing input to the draft revision (which will reflect not only recent program changes announced by DOE, but will also incorporate revisions associated with previous requests for additional information), DCS has compiled the open items identified in the Draft Safety Evaluation Report (DSER) transmitted to DCS 30 April 2002 (Reference 1), and how those items are currently scheduled for resolution relative to the CAR revision.

In an effort to facilitate planning and scheduling of resources, DCS has provides the information below reflecting the results of that compilation. It is DCS's commitment to have responses to the open items in time for the staff to incorporate the information into a revision of the DSER.
