FOR URANIUM ENRICHMENT FACILITY IN HARTSVILLE, TN

MY NAME IS SYDNEY LASHBROOK, I AM A TAX PAYING CITIZEN OF TROUSDALE COUNTY. I AM **OPPOSED** TO THE GRANTING OF LICENSE TO THE LOUISIANA ENERGY SERVICES, LLC, BASED IN PART ON THE FOLLOWIN ISSUES AND I AM ALSO REQUESTING THAT THE PUBLIC COMMENT PERIOD BE EXTENDED DUE TO INSUFFICIENT PUBLIC NOTICE.

FINANCIAL QUALIFICATIONS: I HAVE YET TO SEE NOR CAN I FIND A FINANCIAL STATEMENT FOR THE LES COMPANY. THEY HAVE NO AVAILABLE LIQUID ASSESTS, SINCE LES HAS NO PLANTS IN EXISTENCE, AND ONLY PROMISES OF LIMITED FINANCIAL SUPPORT FROM THE PARTNERS THAT A PART OF THE CONSORTIUM.

IF A LICENSE IS GRANTED TO THIS **FOREIGN** CORPORATION, IT COULD FORCE IT'S ONLY COMPETITOR, USEC OUT OF BUSINESS. THIS IS A FOREIGN OWNED GROUP. THIS RAISES THE QUESTION OF NATIONAL SECURITY. THIS IS POST 9/11 THINGS ARE NOT THE WAY THEY USED TO BE!

I BELIEVE THAT THE PROPOSED SITE WAS NOT CHOSEN BASED ON ~~THE TECHINICAL MERIT OF THE SITE~~ BUT RATHER BECAUSE TVA HAD POSSESSION OF THE PROPERTY AT ONE TIME AND THE LAND WAS AVAILABLE. ALSO, THE HIGH UNEMPLOYMENT RATE IN THE COUNTY AND THE LOW LEVEL OF EDUCATION OF THE CITIZENS WITHIN THE IMPACTED AREA.
