MEMORANDUM AND ORDER

The revised notice of opportunity for hearing in this special nuclear material license amendment proceeding was published in the Federal Register on October 30, 2002.

67 Fed Reg 66,172. Accordingly, as provided in my September 23, 2002 memorandum and order, on or before Friday, November 29, 2002, each of the current hearing requestors shall file with Judge Cole and me and serve upon counsel for the Licensee, Nuclear Fuel Services Inc., one of the following: (1) a substitute hearing request; (2) a supplement to the hearing request currently on file; or (3) a statement to the effect that the hearing requestor has elected to stand on the now existing hearing request. Upon receipt of either a substitute or a supplemented hearing request, the Licensee will then have ten days within which to file and serve its response thereto.

The parties are reminded that all further submissions in this proceeding are to be served in the first instance by electronic mail or facsimile transmission, service to include not only the opposing party but also NRC staff counsel and the Office of the Commission's

Secretary.<sup>1</sup> Simultaneously, hard copies are to be placed in the U.S. mail. In the event that a filing is accompanied by documents that, because of their volume or for some other reason, are not readily susceptible of transmission by either e-mail or facsimile, those documents shall be filed and served by express mail or an equivalent means of expedited delivery.
