The purpose of this modification is to obligate FY'03 funds in the amount of \$56,000.00, thereby increasing the obligated amount of the subject contract from \$2,856,938.00 to \$2,912,938.00. Accordingly, the following changes are hereby made:

Under Subsection B.3 - CONSIDERATION AND OBLIGATION - COST PLUS FIXED-FEE, Paragraphs c and d are deleted in their entirety and substituted in lieu thereof the following:

- "(c) The amount currently obligated by the Government with respect to this contract is \$2,912,938.00, of which the amount of \$2,748,054.72 represents the estimated reimbursable costs, and the amount of \$164,883.28 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through January 2003."

In accordance with FAR Clause 52.232-22 - LIMITATION OF FUNDS, the contractor is not obligated to continue performance under this task order or otherwise incur costs in excess of the amount obligated, until the Contracting Officer notifies the contractor in writing that the obligated amount has been increased. In absence of such notification by the Contracting Officer, the Government is not obligated to reimburse the contractor for any costs in excess of the obligated amount specified herein.
