### **NRC ANNOUNCES OPPORTUNITY FOR HEARING ON NUCLEAR FUEL SERVICES, INC., AMENDMENT REQUEST**

The Nuclear Regulatory Commission is offering the opportunity for a hearing on a license amendment request from Nuclear Fuel Services, Inc. (NFS) to authorize uranium processing operations at a Blended Low-Enriched Uranium Preparation Facility (BPF) within its existing facility located in Erwin, Tennessee. NFS currently manufactures high-enriched nuclear reactor fuel and is constructing a new complex at the Erwin site to manufacture low-enriched nuclear reactor fuel.

The October 11 application is the second of three license amendment requests that NFS plans to support the Blended Low-Enrichment Uranium (BLEU) project, which is part of a U.S. Department of Energy program to downblend and reduce stockpiles of surplus high-enriched uranium through re-use or disposal as radioactive waste. After the high-enriched material is downblended and converted to a low-enriched uranium solution, it will be transferred from the BPF to the new complex.

The first NFS application, which would authorize NFS to construct and operate a Low-Enriched Uranyl Nitrate Storage Building at the Erwin site, was filed February 28. A notice of opportunity for hearing on the first license amendment request was announced in Federal Register notices dated July 9, October 30, and November 12. An NRC Atomic Safety and Licensing Board Judge is currently evaluating hearing applications.

The deadline for requesting a hearing on the second license amendment is 30 days from the date of publication of a Federal Register Notice on this subject, expected shortly. By that time, requests must be filed by anyone whose interest might be affected by the license amendment and who wishes to participate as a party to the proceeding. Requests for a hearing must be filed with the Secretary of the Commission, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555-0001, Attention: Rulemaking and Adjudications Staff. They may also be delivered to the NRC Public Document Room at 11555 Rockville Pike, Rockville, Maryland. A copy of hearing requests should also be sent to the Office of General Counsel, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001.
