Dear Gail:

Enclosed please find the signature page of the Administrative Order by Consent ("AOC"), which our client, Safety Light Corporation, has executed with regard to the Bloomsburg, Pennsylvania Site. Pursuant to our telephone conversation of yesterday, January 30, 2003, I am forwarding this page of the executed AOC to you via facsimile and Federal Express, in order to expedite the processing of the AOC. We are forwarding this page in reliance upon your representation that certain changes will be made to a portion of the current version of the AOC prior to its execution and delivery by your office.

The change that we discussed and which you assured us would be made was to Paragraph 13.1 of the AOC. A portion of that paragraph currently reads: "Payment shall be made by cashier's or certified check within sixty (60) calendar days of receipt of demand. Interest at a rate of the current annualized treasury bill rate shall begin to accrue on the unpaid balance at the end of the thirty day period." After we discussed this paragraph and found this language to be inconsistent at best, you agreed that it would be changed to read as follows: "Payment shall be made by cashier's or certified check within sixty (60) calendar days of receipt of demand. Interest at a rate of the current annualized treasury bill rate shall begin to accrue on the unpaid balance at the end of the sixty (60) day period." It is in reliance upon that representation that we have advised our
