

APPLICANT'S MOTION FOR PAGE LIMIT EXTENSION

As evidenced by Applicant's Motion for Clarification and Setting of Time for Filing Motions for Reconsideration, dated March 20, 2003, Applicant has been considering the filing of a motion for reconsideration with the Board. 
