The meeting is divided into two portions.

First Portion (Conducted from 8:30 a.m. to noon)

Discuss the technical issues from recent requests for additional information and identify a path for resolution of two technical issues:

1. Different structural reliability and risk assessment (SRRA) inputs for different pipe sizes within a segment.
2. Expert panel categorizing segments of low safety significant that are quantitatively high safety significant (one or more risk reduction worth values ≥ 1.005).

Discuss the impact on future applications using an approved generic methodology.
