While updating your company's name and address for the Model C-133 source, Registration Certificate No. NR-0169-S-124-U, dated December 1, 1969, I noted that the following information was missing from the registration sheet:

1. maximum activity; and
2. the correct license code for users, i.e. the Registration Certificate lists "U" for unknown, but I assume it should be "S" for the user to have a specific license.
