11 allowed by this Court.

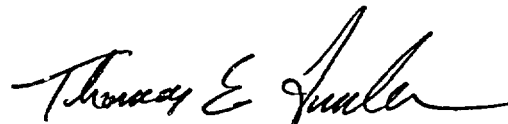
12 10. The Firm represents and warrants that its billing practices comply with all

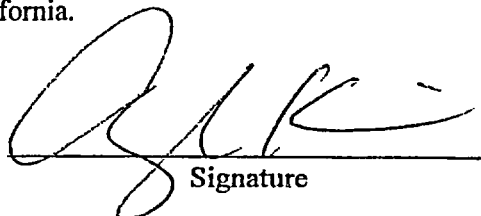
