

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

The purpose of this modification is to (1) exercise the final option of this contract; (2) increase the ceiling of the contract by \$136,500; (3) provide incremental funds in the amount of \$35,000, thus increasing the obligated amount of the contract from \$196,500 to \$231,500; and (4) extend the period of performance. The contract is therefore modified as follows:

1. Option Period 3 is hereby exercised in accordance with FAR 52.217-9 at the prices set forth in Section B.1. As a result, the contract ordering ceiling set forth in Section C.3 is hereby increased by \$136,350 from \$517,800 to \$654,150.

As a result, the first sentences of Section C.3, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), paragraphs (a) and (b) are hereby deleted in their entirety and replaced by the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered and accepted under this contract is \$654,150."

"(b) The amount presently obligated with respect to this contract is \$231,500."

2. In addition, the contract expiration date is changed to April 29, 2004. As a result, the final sentence of Section C.4, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE I (JUN 1988), is deleted as there are no further options available. Furthermore, the first sentence is deleted in its entirety and is hereby replaced with the following:

"The ordering period for this contract shall commence on April 30, 1999 and will expire on April 29, 2004."
