Enclosed for your information is a letter from Framatome ANP, Inc., dated April 18, 2003, requesting Amendment No. 01 to export license XW007 (XW007/01). The purpose of the amendment is to: 1) add 5,000 kilograms stainless steel, contaminated with low-enriched uranium (LEU), to the materials (contaminated zirconium tubing and molybdenum metal pieces) already authorized for export; and 2) add Framatome ANP, Inc., in Lynchburg, VA, as a party to the license for the export of authorized materials. There will be no change to the existing license authorization to export a total of 3.0 kilograms U-235 contained in 60 kilograms uranium-enriched to a maximum of 5.0 percent.

We intend to issue the amendment after you advise us that the Canadian Nuclear Safety Commission (CNSC) has been notified and has no objection, and the required 30-day waiting period has expired.
