Gentlemen:

In accordance with Appendix E of 10CFR50 and 10CFR50.4(b)(5), Entergy is submitting changes and revisions to Waterford 3 Emergency Plan Implementing Procedures. These changed and revised procedures were reviewed in accordance with 10CFR50.54(q) requirements and were determined not to decrease the effectiveness of the Emergency Plan. Most of the changes are the result of recent changes to the Emergency Plan that were approved in NRC Safety Evaluation Report for the Waterford 3 Response Time submittal dated December 23, 2002 (Adams Number ML023570329).

The following procedures are included in this submittal:

1. EP-001-020 (Revision 26, Change 1), Alert. Changed terminology to implement response time submittal.
2. EP-001-030 (Revision 25, Change 1), Site Area Emergency. Changed terminology to implement response time submittal.
3. EP-001-040 (Revision 26, Change 1), General Emergency. Changed terminology to implement response time submittal.
4. EP-002-010 (Revision 28, Change 2), Notification and Communications. Changed terminology to implement response time submittal.
