I seek all direct correspondence between the listed members or their staff and your Agency, including letters, reports, requests and other relevant material. I am not seeking any secondary material such as phone logs, e-mails, notations of conversations and so on.

In particular, information regarding individuals (other than the members of Congress listed in this request) should be redacted where disclosure would be an unwarranted invasion of individual privacy. [Per the exemption provided by Congress in 5 U.S.C. 552(b)(6)]

I also request that you state the specific legal and factual grounds for withholding any documents or portions of documents. And please identify each document that falls with scope of this request but is withheld from release.

If requested documents are located in, or originated in, another installation or bureau, please refer this request or any relevant portion of this request to the appropriate installation or bureau.
