SUBJECT: SUMMARY OF THE APRIL 15, 2003, PUBLIC MEETINGS TO DISCUSS THE
MANUAL CHAPTER 0350 PROCESS AT DAVIS-BESSE

On April 15, 2003, the Nuclear Regulatory Commission (NRC) held two public meetings at the Camp Perry Clubhouse in Port Clinton, Ohio. The first meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss recent inspection results and the licensee's Return to Service Plan for Davis-Besse Nuclear Power Station.
