Dear Mr. Mezaraups:

I am writing in response to your letter of May 4, 2003, to Chairman Nils Diaz of the U.S. Nuclear Regulatory Commission (NRC). I would like to thank you for your interest in NRC business opportunities, but at this time we do not have a need for such a consulting program.

There are a number of sources to assist you in obtaining information about potential business opportunities. The NRC publicizes and posts proposed business opportunities valued at greater than \$25,000 on the FedBizOpps Web site at <http://www.fbo.gov>. Once at this site, select "Vendors" located toward the lower center of your screen. The next screen is "Search Agency by Acronym and Alphabetic Order." Search for NRC business opportunities either in the agency acronym menu or in the alphabetized list at the bottom of the page. Once you find NRC, select "Posted Dates". Once you have selected a procurement of interest, select "Synopsis", then select "Register To Receive Notification", and follow the guidelines at that screen to receive further notice about that particular NRC procurement.

FedBizOpps also offers an e-mail notification service. This service allows vendors to fill out a subscription form in order to receive e-mail notification when notices are posted to FedBizOpps that fit the criteria the vendor selects on the form, such as a notice from a particular agency/office/location, a procurement classification code for a certain type of work, set-aside type, or place-of-performance zip code. To subscribe, go to the FedBizOpps Web site, select "Vendors Notification Service" located under "Related Links". Select a notification option and follow the instructions on the screen that follow.

NRC utilizes PRO-NET (<http://pronet.sba.gov/>) as the primary database to identify small and disadvantaged businesses to fulfill our requirements.

NRC also posts to its Web site <http://www.nrc.gov/who-we-are/contracting.html>, notices of proposed contract actions with estimated values between \$10,000 and \$25,000. Contact the designated Division of Contracts staff member for more information regarding a specific procurement. Also published on the Web site is the NRC's supplement to the Federal Acquisition Regulation, the NRC Acquisition Regulation (48 CFR Chapter 20).
