We are responding to your letter to President George W. Bush, dated January 24, 2003. In your letter, you raised several concerns about the Louisiana Energy Services' (LES') proposed uranium enrichment facility in Hartsville, Tennessee.

Your concerns related to liquid and air effluents, physical security, tornado protection, and handling of classified information. Each of these concerns is an area that will be evaluated in the U.S. Nuclear Regulatory Commission's (NRC's) review of the LES application, if LES decides to proceed with the project. NRC will also prepare an environmental impact statement (EIS) for the project.

We would like to point out that the public will have several opportunities to formally participate in the LES licensing process, should LES decide to proceed. For example, after LES submits its license application and environmental report to NRC, the public will have an opportunity to petition for a hearing. The public will also have an opportunity to provide information in NRC's EIS scoping process and to comment on NRC's draft EIS. In addition, meetings between the staff and LES have been, and will continue to be noticed, and the public may attend meetings in accordance with the Commission's policy on public meetings.
