

The purpose of this modification is to extend the term of the contract through July 31, 2003, in accordance with Federal Acquisition Clause 52.237-3, entitled, "Continuity of Services," and Ruland Associates, Inc.'s, cost proposal dated, April 15, 2003, which is hereby incorporated by reference and made a part hereof. As result of this action, the ceiling amount is increased by \$152,350.00 from \$3,122,997.00 to \$3,275,347.00. In addition, incremental funding in the amount of \$104,000.00 is being provided which increases the obligation amount from \$3,122,997.00 to \$3,226,997.00.

Accordingly, the following changes are hereby made:

1. Under Subsection B.3 - CONSIDERATION AND OBLIGATION - COST PLUS FIXED-FEE, Paragraphs a, c, and d are deleted in their entirety and substituted in lieu thereof the following:

"(a) The total estimated cost to the Government for full performance of this contract (Base Years, Option Year 1 and Option Year 2) is of \$3,275,347.00, of which the sum of \$3,089,949.43 represents the estimated reimbursable costs, and the amount of \$185,397.57 represents the fixed fee.

(c) The amount currently obligated by the Government with respect to this contract is \$3,226,997.00, of which the amount of \$3,044,336.80 represents the estimated reimbursable costs, and the amount of \$182,660.20 represents the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through June 15, 2003."

2. Subsection F.4 - DURATION OF CONTRACT PERIOD, is deleted in its entirety and substituted in lieu thereof the following:

"This contract shall commence on May 16, 1998, and will expire on July 31, 2003."
