


The CLINs on the attached OF 348 are hereby added to this delivery order for the contractor to complete and issue the final audit report under the aforementioned contract including assistance for negotiations. The delivery order not-to-exceed amount is increased by \$16,559.48 (includes \$2859.48 overage) from \$29,500 to \$46,059.48. The Contractor shall submit the final completed audit report to the NRC by 6/30/03. The period of performance of this deliver order will run through 8/31/2003 for negotiation support.
