

The purpose of this modification is to (1) obligate additional funds in the amount of \$40,000 to allow for the Office of International Program's efforts to continue to provide nuclear safety assistance to help the Lithuanian Atomic Energy Safety Inspectorate (VATESI) cope with a range of urgent regulatory issues associated with the operation at Ignalina Nuclear Power Plant Unit 2 (INPP2); (2) increase the contract's ceiling by \$73,356; (3) amend the Statement of Work (SOW) to reflect the continuation of licensing reviews aimed at enhancing VATESI's capability for carrying out a range of activities, including activities associated with the Diverse Shutdown System and the Safety Evaluation Report for INPP2; (4) extend the period of performance through September 30, 2003; and (5) change the project officer. Accordingly, the following changes are made:

1. Section B.3, CONSIDERATION AND OBLIGATION –COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) , paragraphs (a), (c) and (d) are hereby deleted and substituted with the following:

"(a) The total estimated cost to the Government for full performance of this contract is \$512,910, of which the sum of \$483,102 represents the estimated reimbursable costs, and of which \$29,808 represents the fixed fee.

"(c) The amount currently obligated by the Government with respect to this contract is \$479,554, of which the sum of \$449,746 represents the estimated reimbursable costs, and of which \$29,808 represents the fixed fee.

"(d) It is estimated that the amount currently allotted will cover performance through September 30, 2003."

2. Section C, DESCRIPTION/SPECIFICATIONS/STATEMENT OF WORK, is modified to add the three (3) pages attached to this modification.
3. Section F.6, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), is deleted in its entirety and replaced with the following:

"This contract shall commence on April 25, 2001 and will expire on September 30, 2003."

4. Section G.1, 2052.215-71, PROJECT OFFICER AUTHORITY, the name, address and telephone information stated in paragraph (a) are deleted in their entirety and replaced with the following:
