This modification increases the total funds obligated under this contract by \$174,000.00 from \$220,000 to \$394,000.00. Therefore, paragraphs (c) and (d) of Section B.3 CONSIDERATION AND OBLIGATION are revised to read as follows:  
\*(c) The amount currently obligated by the Government with respect to this contract is \$394,000.00, of which the sum of \$378,240.00 represents the estimated reimbursable costs, of which \$15,760.00 represents the fixed fee.\*
