The meeting continued with a presentation of probability of prior cycle detection (POPCD) including responses to the NRC questions regarding that method. PG&E further discussed the applicability of ARC correlation to DCPP Unit 2.

PG&E provided responses to the verbal questions from the staff and discussed a tentative schedule for submittal of the POPCD method.
