This letter responds to your April 28, 2003, letter to Ms. Leah Tremper of my staff. I am treating your letter as a request to be relieved from the Fiscal Year (FY) 2003 annual license fee for your terminated NRC License No. 49-27510-01. I am canceling your FY 2003 annual fee invoice based on the following considerations.

You have indicated that: (1) upon receipt of the FY 2001 annual fee invoice dated March 5, 2001, you began steps to sell your portable gauges to Qal-Tek; (2) you sent a letter in the Fall 2001 to the NRC's Region IV office requesting termination of your license; (3) you paid the FY 2001 and FY 2002 annual fee; (4) you resubmitted the required documentation to terminate your license to Region IV on November 29, 2002; and (5) the NRC terminated your license on March 19, 2003. You have provided the bill of sale and shipping tickets indicating that you sold your portable gauges on March 30, 2001. However, you were not able to provide a copy of your Fall 2001 letter requesting license termination nor does our Region IV office have a record of that letter.

The NRC's 10 CFR Part 171 annual fee regulations provide that the annual fee is avoided in those cases where the licensee files for termination before October 1 of the FY, and also provides for a proration for terminations filed between October 1 and March 31 of the FY. Based on your license termination date, your FY 2003 annual fee would be reduced 50 percent in accordance with the proration provision of NRC's regulations. However, in light of the circumstances surrounding your efforts to have your license terminated, I am granting an extension of time to file for license termination to November 29, 2002, and therefore have canceled the FY 2003 annual fee invoice.
