RE: Name Change on Device Registrations

I am writing to you, to request an amendment to the Registry of Radioactive Sealed Source and Devices Safety Evaluation of Sealed Source for all the sources and devices listed in Annex 1. This amendment is required to change the name and address of MDS Nordion as listed below. Please note that the quality assurance and quality control programs will remain the same. The technical staff administering these programs has not changed. This request is solely a name and address change and does not represent a change in design, labelling or operating procedures. The quality assurance program has not been changed.

- 1) The name of our corporation was changed from MDS Nordion Inc. to MDS (Canada) Inc. on November 1st, 2001. The name change is the result of a statutory amalgamation. MDS Nordion is now a division of MDS (Canada) Inc. MDS Nordion without the "Inc." will continue to be the name under which MDS (Canada) Inc. carries on business. It is for this reason that we would like to request that our corporate name found on the Registry of Radioactive Sealed Source and Devices Safety Evaluation of Sealed Source listed in Annex 1 be changed to "MDS Nordion, a Division of MDS (Canada) Inc." This is strictly a name change exercise. The ownership, management and operation of our company remain unchanged and the same. Please refer to the enclosed letter from our Legal Counsel, Re: MDS Nordion Inc. - Notice of Change of Corporation Name.


- 2) Our address has changed from Kanata to Ottawa. The city of Kanata was amalgamated along with a dozen other municipalities into the city of Ottawa on January 1st 2001. The remainder of our address and other co-ordinates remain unchanged. We would appreciate if our address could be changed from the municipality of Kanata to the municipality of Ottawa on the Registry of Radioactive Sealed Source and Devices Safety Evaluation of Sealed Source listed in Annex 1.
