Dear Mr. Baker:

I refer to your letter dated May 2, 2003 regarding the application from Framatome ANP requesting Amendment No. 01 to export license XW007 (XW007/01) to, inter alia, add 5,000 kilograms of stainless steel contaminated with low enriched uranium to the materials (contaminated zirconium tubing and molybdenum metal pieces) already authorized for export.

We have informed the Canadian Nuclear Safety Commission (CNSC) of the proposed amendment and have received the enclosed confirmation that there are no CNSC objections to the import into Canada of the uranium-contaminated stainless steel exported by Framatome ANP.

In view of the foregoing, the proposed additional export to Canada under XW007/01 would appear to be consistent with the Code of Practice on Transboundary Movement of Radioactive Waste.

Dear Mr. Baker:

I refer to your letter dated April 16, 2003 regarding the request from PermaFix/Diversified Scientific Services, Inc. (DSSI) for Amendment No. 02 to export license XW002. The amendment would add for return to Canada: 1) 630 kilograms of non-conforming waste containing approximately: a) 300 Ci of tritium and other fission product radionuclides; and b) 150 kilograms of heavy water inadvertently shipped by Ontario Power Generation to DSSI in 2002; 2) extend the expiration date to December 31, 2005; and 3) to correct a spelling error in the ultimate consignee's address.

The Canadian Nuclear Safety Commission has confirmed (see enclosure) that there is no objection to the proposed return to Canada of the non-conforming waste. In view of the Canadian Government confirmation, the return to Canada of this material would appear to be consistent with the Code of Practice on Transboundary Movement of Radioactive Waste.
