Chief, Bureau of Radiation Protection

The Ohio Department of Health is seeking a dynamic, knowledgeable, and experienced leader for the position of Chief, Bureau of Radiation Protection. The Chief of the Bureau of Radiation Protection is responsible for overseeing all activities regarding radiation protection in Ohio. Ohio is an Agreement State with the Nuclear Regulatory Commission. The Bureau Chief provides direction and leadership to a staff of 70 and assures the successful operation of all the Bureau's radiation protection programs including:

- **Radioactive materials**
- **Radiologic technologist licensure**
- **Nuclear power plant emergency response**
- **Low level waste management**
- **Health physics oversight of federal site cleanup**
- **Radiation generating equipment**
- **Radon**
- **Environmental monitoring**
- **Licensing of diagnostic and radiation therapy centers**
- **An extensive decommissioning program associated with all types of regulated facilities.**

The Bureau Chief directs the development and implementation of programmatic policies, protocols and procedures and represents the Director of Health on various radiation related state boards and commissions as well as national radiological organizations. The Chief of the Bureau of Radiation Protection also serves as the primary person responsible for coordinating agency interactions with other state and federal agencies including the U.S. Nuclear Regulatory Commission.

Qualified candidates will possess demonstrated leadership and administrative skills in a multi-faceted program setting and have extensive knowledge and experience with radiologic health program development and/or oversight. Qualified candidates must also possess **(1)** A Master's degree in health physics or radiation science field, five years of progressively responsible broad-based management experience in radiological health, and a health physicist certification from the American Board of Health Physics or board eligible as determined by the current criteria of the American Board of Health Physics; **OR (2)** A Master's degree in a health related field and five years of progressively responsible broad-based management experience in radiological health; **OR (3)** A health physicist certification from the American Board of Health Physics or board eligible as determined by application of the current criteria of the American Board of Health Physics and six years of broad-based management experience in radiological health. A Master's degree in health physics, radiation science, or other health-related field may be substituted for one year of the required experience.
