The purpose of this modification is to (1) partially exercise the option period (under Line Item No. 5 (see attached price schedule for period), and extend the subject contract through November 30, 2003, and (2) provide funding in the amount of \$11,567.26 which increases the obligated amount from \$68,760 to \$80,327.26. Accordingly, the following changes are hereby made:

1. Section B.4, "CONSIDERATION AND OBLIGATION-FIRM FIXED PRICE (JUNE 1988)," the sentence is hereby revised to read as follows:

"The firm fixed price of this contract is \$80,327.26."

2. Section F.2, "DURATION OF CONTRACT PERIOD (MAR 1987), ALTERNATE 2 (MAR 1987)," the paragraph is hereby revised to read as follows:

"This contract shall begin with a base period from 9/30/02 through 11/30/03, an option period from 12/1/03 through 9/30/04 (subject to availability of FY 2004 funds), and 3 additional one-year options thereafter.

All other terms and conditions under this contract remains unchanged.

A summary of obligations for this contract, from award date through the date of this action, is given below:
