This Modification No. 16 accomplishes the following:

- (1) Revise the number and location of estimated courses to accommodate one (1) "Root Cause/Incident Investigation Workshop Presentation" held in NRC Region 1, for 20 students on November 18-22, 2002, at a total cost of \$32,825, in accordance with the NRC Project Officer's e-mail message dated 1/21/2003. As a result, (a) the estimated number of presentations under line item 3.a.(a.1) "Root Cause/Incident Investigation Workshop Presentation" for the NRC Headquarters in FY 2002 is reduced from 1 to 0 with a reduction in the firm fixed price by \$21,427 from \$21,427 to \$-0-; (b) the estimated number of presentations under line item 5.a.(b) "Two-day Root Cause/Incident Investigation Refresher Training Course Presentations" for NRC Region 1 in FY 2003, is reduced from 1 to 0 with a reduction in the firm fixed price by \$11,398 from \$11,398 to \$-0-; and (c) the estimated number of presentations under line item 3.a.(b) "Root Cause/Incident Investigation Workshop Presentation" for the NRC Region 1 in FY2003 is increased from 0 to 1 with an increase in the firm fixed price by \$32,825 from \$-0- to \$32,825 (includes five (5) additional students and a second instructor in the class).
- (2) Incorporate under subsection B.8 SUPPLIES OF SERVICES AND PRICES/COST a decrease in the total estimated amounts for all courses in FY 2002, as reflected in modifications number fourteen (14) through sixteen (16), from \$224,356 to \$209,820.
- (3) Incorporate under subsection B.8 SUPPLIES OF SERVICES AND PRICES/COST an increase in the total estimated amounts for all courses in FY 2003, as reflected in modifications number fourteen (14) through sixteen (16), from \$217,152 to \$259,095.
