Subject: Supplemental Response to Order for Compensatory Measures Related to Access  
Authorization

Ladies and Gentlemen:

By letters dated January 24, 2003 (L-03-013), January 27, 2003 (Serial Number 2832), and January 24, 2003 (PY-CEI/NRR-2686L), the FirstEnergy Nuclear Operating Company (FENOC) responded to the Order for Interim Safeguards and Security Compensatory Measures issued on January 7, 2003 for the Beaver Valley Power Station (BVPS) Units 1 and 2, the Davis-Besse Nuclear Power Station (DBNPS), and the Perry Nuclear Power Plant (PNPP), respectively.

This letter provides a supplemental response to clarify and further define the information previously submitted regarding Compensatory Measure B.1.3(c) of Attachment 2 of the Order. FENOC has implemented the requirements of Item B.1.3(c) at all three FENOC facilities through utilization of information available through the Bureau of Citizenship and Immigration Services (BCIS - formerly the Immigration and Naturalization Service, or INS). FENOC is utilizing the BCIS Systematic Alien Verification Entitlements (SAVE) program for non-U. S. Citizens applying for unescorted access. In addition, FENOC is utilizing the Basic Pilot program through BCIS for all new hires.
