The Committee to Review Generic Requirements (CRGR) will meet Tuesday, July 22, 2003, from 1:00 p.m. to 3:00 p.m. in room T-2 B-5.

Mr. Daniel Dorman and Ms. Christina Antonescu will discuss the following topic: Regulatory Guide 1.180, Revision 1, "Guidelines for Evaluating EMI/RFI in Safety-Related I&C Systems.

If a CRGR member cannot attend the meeting, it is his or her responsibility to ensure that an alternate, who is approved by the CRGR Chairman, attends the meeting. Cupidon) as soon as possible before the meeting; (5) providing 10 copies of presentation materials for distribution on the day of the meeting; (6) and ensuring that agenda modifications are coordinated with the CRGR staff and others involved with the presentation. Sponsoring Division Directors or higher management should attend meetings addressing agenda items under their purview.
