
STATE OF UTAH'S REQUEST FOR AN ENLARGEMENT OF PAGES

UTAH E/CONFEDERATED TRIBES F AND UTAH S

The State has until July 14, 2003 to respond to "Applicant's Justification for Withholding Portions of Memorandum and Order (Rulings on Summary Disposition Motion and other Rulings Relating to Remand from CLI-00-13), Partial Initial Decision (Contention Utah E/Confederated Tribes F), and Partial Initial Decision (Contention Utah S) from Public Disclosure" dated July 3, 2003. In addition to the Justification filing, the Applicant also submitted a markup of the three decisions at issue, in which it requests substantial redactions to the Board's rulings. The State requests an enlargement from ten to fifteen pages for its response. This request is reasonable because the State must address redactions from the Board's three lengthy rulings (totaling about 240 pages). The State must also address the legal standard and respond to the seven categories PFS has claimed justify its redactions.

The State has contacted counsel for the Staff and the Applicant. Counsel for the Staff does not object to the State's request. Counsel for the Applicant does not object to the State's request provided it is allowed to file a 10 page reply to the State's response.
