SPECIFICATION TASK FORCE TRAVELER 448, "CONTROL ROOM
HABITABILITY" (TAC NO. MB7186)

On July 11, 2003, U.S. Nuclear Regulatory Commission (NRC) staff met at Rockville, Maryland, with members of the Nuclear Energy Institute (NEI) Control Room Habitability and Technical Specification Task Forces to discuss Technical Specification Task Force (TSTF) Traveler 448, "Control Room Habitability." The proposed Traveler would modify the Standard Technical Specifications to address the potential for excessive inleakage that can increase the radiation exposure to control room operators. The proposed changes would also establish a control room integrity program which would contain programmatic components that would work together to support control room habitability requirements specified in General Design Criterion 19, "Control Room," of Part 50 to Title 10 of the *Code of Federal Regulations*, Appendix A, "General Design Criteria for Nuclear Power Plants."

During the meeting, NRC staff and the Task Force members discussed a written description of proposed revisions to TSTF Traveler 448, developed by the Task Forces in response to NRC staff comments that were provided to NEI by letter dated July 1, 2003 (Agencywide Documents Access and Management System (ADAMS) Accession Number ML031820580). Based on issues raised during the meeting, the Task Forces plan to prepare additional revisions to support the staff's review of TSTF Traveler 448.

Members of the public were in attendance. Public Meeting Feedback forms were not received.
