### **NRC TO HOLD PUBLIC MEETINGS REGARDING DRAFT ENVIRONMENTAL REPORT FOR GINNA NUCLEAR PLANT LICENSE RENEWAL APPLICATION**

Members of the public will have an opportunity on Thursday, August 7<sup>th</sup>, to comment on a draft report that assesses the environmental impact of extending the operating license for the R.E. Ginna nuclear power plant. Rochester Gas & Electric (RG&E) Corp. has submitted an application to renew the license of the plant, located in Wayne County, N.Y., for an additional 20-year period.

The NRC will hold two meetings on August 7<sup>th</sup> to accept comments, with one session scheduled to begin at 1:30 p.m. and another at 7 p.m. Both meetings, which are scheduled to last up to three hours each, will take place at the Fireman's Exempt Hall, 1840 Route 104, Ontario, N.Y. NRC staff will be available for an hour prior to the start of each meeting for informal discussions of the report.

Interested parties may pre-register to attend or present oral comments at the meetings by contacting Robert G. Members of the public may also register 15 minutes before each session to provide oral comments. The duration of individual comments may be limited by the time available, depending on the number of persons who register. Written comments on the draft report will also be considered by the NRC staff. Comments can be submitted by mail to the Chief, Rules and Directives Branch, Division of Administrative Services, Mail Stop T-6 D59, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555-0001. The public comment period ends on September 16.

Under NRC regulations, the original operating license for a commercial nuclear power plant has a term of 40 years. The license can be renewed for up to an additional 20 years if NRC requirements are met. The current operating license for the Ginna plant is due to expire on September 18, 2009.

RG&E submitted its license renewal application for the plant on July 30, 2002. As part of its application, the company submitted an environmental report. The NRC staff reviewed the report

and performed an on-site audit. The staff also considered comments made during the environmental scoping process, including those comments offered at public meetings held on November 6, 2002, in Webster, N.Y.

Based on its review, the NRC staff has preliminarily recommended that the Commission determine the adverse environmental impacts of license renewal for the Ginna plant are not so great that preserving the option of license renewal for energy planning decision-makers would be unreasonable.

When issued in its final form, the statement will be a Ginna-specific supplement to the "Generic Environmental Impact Statement (GEIS) for License Renewal of Nuclear Plants," (NUREG-1437).
