SUBJECT: OMB ISSUES GRANTS MANAGEMENT POLICIES

On July 15, 2003, the Office of Management and Budget (OMB) announced to agency heads the issuance of several grants management policies requiring agency implementation within the next 3 months. In summary, the new OMB policy increases the dollar threshold for audits, requires agencies to use a standard format in announcing Federal grant opportunities, create Internet announcement postings, and requires applicants (other than individuals) to include in their grant application a Dun and Bradstreet Data Universal Numbering System (DUNS) number.

Under Management Directive 11.6, the Director, Division of Contracts is responsible for the management and coordination of NRC's grant program. Therefore, I am attaching the subject OMB memorandum, along with the referenced Public Law 106-107 (Federal Financial Assistance Management Improvement Act of 1999) and the OMB Federal Register notices reflecting these OMB policy changes that require NRC implementation.
