

The purpose of this modification is to: (1) increase the contract ceiling amount by \$17,971 from \$582,000 to \$599,971 in accordance with the contractor's proposal dated 8/1/03, for the purchase of APEX-1000 Replacement Parts, (2) increase the obligated amount by \$17,971 from \$282,000 to \$299,971, and (3) revise Section H.8 to identify the replacement parts. Accordingly, the contract is hereby modified as follows:

1. Under Section B.3, Consideration and Obligation, paragraphs (a) and (b) are revised as follows:

"(a) The total estimated cost to the Government for full performance of the base period under this contract is \$599,971.

(b) The amount presently obligated by the Government with respect to this contract is \$299,971."

2. Under Section H.8, Contractor Acquired Government Equipment/Property, paragraph (a) is revised as follows:

"(a) The contractor is authorized to acquire and/or fabricate the equipment/property listed below for use in the performance of this contract:

Ronin Gamma Densitometer - base period  
4 - Variable Speed Drives for Reactor Coolant Pumps  
1 set - Process Controller Parts  
1 - LabView Data Acquisition Software Upgrade"

All other terms and conditions remain unchanged.

This modification obligates FY 03 funds in the amount of \$17,971.
