SUBJECT: MINUTES OF THE COMMITTEE TO REVIEW GENERIC
REQUIREMENTS MEETING NUMBER 387

The Committee to Review Generic Requirements (CRGR) held special Meeting No. 387 on July 28, 2003, from 12:30 P.M. to 2:30 P.M., with the attendees listed in Attachment 1. The purpose of this meeting was to review the proposed Bulletin 2003-0X, "Leakage From Reactor Pressure Vessel Lower Head Penetrations and Reactor Coolant Pressure Boundary Integrity," ADAMS Accession No. ML032030040. The slide presentation is located in ADAMS, Accession No. ML032050040.

Mr. Edmund Sullivan, Office of Nuclear Reactor Regulation, briefed the CRGR on the proposed Bulletin 2003-0X, "Leakage From Reactor Pressure Vessel Lower Head Penetrations and Reactor Coolant Pressure Boundary Integrity."

Following discussion of the proposed package, the CRGR recommended and the staff agreed that certain revisions were needed to be consistent with the staffs and CRGR's view that the bulletin is not imposing backfits.

The following is a list of the CRGR recommendations that the staff agreed to include in the revision of the CRGR package:

- 1) The staff agreed to add language in the bulletin to address why the previous licensee responses (e.g., previous bulletins on vessel head inspection programs) did not provide the information that is now being requested in this bulletin.
- 2) The text in page 4 of the bulletin, paragraph 3, presented the implication of a "new requirement". The staff agreed to modify the text to not imply a new requirement.
- 3) On page 4 of the bulletin, first sentence under the section, Applicable Regulatory Requirements and also in the RIS, under the section, Summary of Issue, second paragraph, first sentence, the staff agreed to clarify the intent of the sentence regarding existing regulatory requirements.
- 4) On page 6, Item "1 (c)" under Requested Information, staff agreed to revise the wording to remove the implication that licensees are required to take action.

The CRGR and the staff agreed that another CRGR review would not be necessary and that the CRGR Chairman and staff would review the revised documents to verify that the modifications have adequately addressed the CRGR concerns.

Subsequent to the CRGR review, staff has provided a revised version of the bulletin that addresses the CRGR recommendations and concerns (ADAMS ML032200499).
