SUBJECT: MINUTES OF THE COMMITTEE TO REVIEW GENERIC
REQUIREMENTS MEETING NUMBER 386

The Committee to Review Generic Requirements (CRGR) held special Meeting No. 386 on July 22, 2003, from 1:00 P.M. to 3:00 P.M., with the attendees listed in Attachment 1. The purpose of this meeting was to review the proposed Regulatory Guide 1.180, Revision 1 (DG1119), "Guidelines for Evaluating EMI/RFI in Safety-Related I&C Systems," ADAMS Accession No. ML031970341 and the slide presentation is located in ADAMS, Accession No. ML032130043.

Mr. Daniel Dorman, Office of Nuclear Reactor Regulation and Ms. Christina Antonescu, Office of Nuclear Regulatory Research, briefed the CRGR on the proposed Regulatory Guide 1.180, Revision 1 (DG1119), "Guidelines for Evaluating EMI/RFI in Safety-Related I&C Systems."

Following discussion of the proposed package, the CRGR recommended and the staff agreed to incorporate several clarifying changes to assure that the Regulatory Guide did not include any backfit implications.

The following is a list of the CRGR recommendations that the staff agreed to include in the revised Regulatory Guide:

- 1) On page 1, paragraph 1 in the draft Regulatory Guide, staff agreed to clarify the status of the previous version of the Regulatory Guide.
- 2) On page 5, paragraph 1, sentence 3, starting with the words, "The previous. . ." in the draft Regulatory Guide, staff agreed to clarify that previous guidance continued to be acceptable.
- 3) Staff agreed to verify whether the footnote 2 on page 2 of the regulatory guide should refer to Tier 2* information under 10 CFR Part 52 rather than Tier 2 information.
- 4) Staff also agreed to modify the implementation section on page 37, second paragraph to use language consistent with Revision 0 of the Regulatory Guide. Specifically, the words, "licensee compliance" are to be replaced with the Revision 0 text for that section.

The CRGR and the staff agreed that another CRGR review would not be necessary and also, that the CRGR Chairman and staff would review the revised documents to verify that the modifications have adequately addressed the CRGR concerns.

Subsequent to the CRGR review, staff has provided revised language for the Regulatory Guide that addresses the CRGR recommendations and concerns (ADAMS ML032120607, Revised Regulatory Guide, ADAMS ML032130011).
