The staff provided a detailed request for additional information (RAI) to the Westinghouse Owners Group (WOG) on June 16, 2003.

Based on a recent discussion with Mr. Virgil Pagen of your staff, the WOG will submit a new revision to WCAP-15691, along with a response to the RAI sometime in the fourth quarter of 2003.
