

The purpose of this modification is to exercise the fourth and final option year under the subject contract in accordance with Paragraph C.7 - Option to Extend the Term of the Contract, which shall be billed in accordance with the rates reflected under Paragraph B.15 - Schedule of Prices/Costs. As a result of exercising the option period, Paragraph B.20 - Duration of Contract period is revised to extend the contract performance period from September 29, 2003 to September 29, 2004. In addition, Paragraph B.18 - Consideration and Obligation -- Work Orders, Subparagraph (a) is revised to increase the ceiling amount of the subject contract by \$500,000 from \$1,990,303 to \$2,490,303. In addition, under Paragraph B.18 - Consideration and Obligation -- Work Orders, Subparagraph (b) is revised to increase the obligated amount of the subject contract by \$140,000 from \$1,700,303 to \$1,840,303.

Note: The contractor waives its right to receipt of a preliminary notice as reflected in its e-mail to the Government dated August 4, 2003, which is hereby incorporated by reference and made a part hereof this contract.

Accordingly, the following changes are hereby made:

1. Under Paragraph B.18 - Consideration and Obligation, the first sentence under Subparagraph (a) and (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18 CONSIDERATION AND OBLIGATION

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$2,490,303.

(b) The amount presently obligated with respect to this contract is \$1,840,303."

2. Under Paragraph B.20 - Duration of Contract Period, is hereby deleted in its entirety and substituted in lieu thereof the following:

B.20 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on September 30, 1999 and will expire on September 29, 2004. Any orders issued during this period shall be completed within the times specified in the order, unless otherwise specified herein. (See 52.215-18 - Ordering.)
