The purpose of this modification is to provide incremental funding in the amount of \$23,000.00 to allow for the continuation of services under the contract. Therefore, the total funds obligated under this contract are increased from \$489,000.00 to \$515,000.00. Accordingly, the contract is modified as follows:

Under Section **B.4 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)**, the first sentence of paragraph (b) is **DELETED** entirely and **REPLACED** with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$515,000.00."

All other terms, including the contract ceiling amount of \$544,260.00, remain the same.
