**PETITIONERS' REQUEST FOR
IMMEDIATE RULING ON
'PETITIONERS' MOTION
FOR PERMISSION TO FILE
OVERLENGTH
JOINT OPENING BRIEF'**

The Petitioners respectfully request that this Court immediately rule on the Petitioners' pending motion (dated 15 August 2003) for permission to file a Joint Opening Brief of not more than 1850 lines of text.

Respondents United States and the Nuclear Regulatory Commission and Intervenor Private Fuel Storage, LLC, have already filed their oppositions to the

pending motion. On Friday, 22 August 2003, the Petitioners advised the clerk orally that they would not be filing a reply. Thus, the motion is ready for disposition.

The Petitioners ask for an immediate ruling (that is, as early as possible in the day on Monday, 25 August 2003) because:


1. the Petitioners' Joint Opening Brief is due on Wednesday, 27 August 2003;
2. the principal authors of that Brief, Mr. Lee and Mr. Stewart, must travel to Albuquerque, New Mexico, on Monday, 27 August 2003, to participate in oral argument before the Tenth Circuit Court of Appeals in a related case on Tuesday, 28 August 2003;
3. the printing and binding process for the Brief must begin on Tuesday, 28 August 2003;
4. therefore, the authors must know before their departure on Monday the allowed length of the Brief.

For all the foregoing reasons, the Petitioners' respectfully request that this Court immediately rule on the Petitioners' pending motion for permission to file a Joint Opening Brief not exceeding 1850 lines of text.
