ORDER

On August 26, 2003, Georgians Against Nuclear Energy (GANE) filed a motion for an extension of time to respond to Duke Cogema Stone & Webster's (DCS) motion for summary disposition of GANE's contention 3. GANE seeks an extension of time until twenty days after the Board rules on DCS's pending summary disposition motion of consolidated contention 11 in which GANE argues that a motion for summary disposition is not permitted in this Subpart L proceeding. GANE's motion for an extension of time is denied. The denial of GANE's motion is without prejudice to GANE filing, if appropriate, an unconditional extension motion. Although it has not yet issued a decision on DCS's motion for summary disposition of consolidated

contention 11, the Board notes that it is not favorably impressed by GANE's argument that summary disposition motions are not permitted in this proceeding.

It is so ORDERED.
