The NRC staff has performed an acceptance review of the TR. We have found that the material presented is complete enough to begin a review. The staff expects to complete its review by September 15, 2003, and estimates that the review will require approximately 400 staff hours.

Section 170.21 of Title 10 of the Code of Federal Regulations requires that TRs are subject to fees based on the full cost of the review. You did not request a fee waiver; therefore, staff hours will be billed accordingly. To enable us to complete this review on schedule, close and frequent communications between our technical staffs will be required.
