## **Summary of Changes to NUREG-1748**

The following substantive changes were made to the guidance based on comments received from NRC staff. Minor editorial and content changes are not included in the summary.

1. Expanded and reorganized Chapter 1, "Introduction to This Guidance Document," to include more general aspects of the NEPA process:
  - a. Expanded and Reorganized Section 1.3, "Initiation of the Environmental Review," to include:
    - Instructions for submitting NEPA documents to EPAB for review;
    - Information on pre-application meetings; and
    - Information on acceptance reviews (moved from previous Section 3.1).
  - b. New Section 1.4, "Consultations," which consolidates general information concerning Section 7 consultations with the U.S. Fish and Wildlife Service and Section 106 consultations with the State Historic Preservation Officer.
  - c. Expanded Section 1.6, "Utilizing Existing Environmental Analyses," (formerly Section 1.3).
  - d. New Section 1.7, "Public Meetings."
  - e. New Section 1.8, "Sensitive Information."
2. Expanded Chapter 2, "Preparation and Use of Categorical Exclusions," to include the background for each CATX from the 1984 Statements of Consideration for the Final Rulemaking.
3. Revised Chapter 3, "Preparing an Environmental Assessment":
  - a. Moved discussion of acceptance review to Section 1.3.3.
  - b. Expanded discussion of EA format to include:
    - New discussion of simple licensing action, Section 3.3; and
    - Revised discussion of complex licensing action, Section 3.4 (formerly Section 3.2).
  - c. Clarified information regarding consultations (formerly Section 3.2.9). General consultation information was consolidated in Section 1.4, "Consultations."
  - c. Updated and clarified information in Section 3.5, Review of a Draft Environmental Assessment Document."
  - d. Updated and clarified information in Section 3.6, "Documenting a Finding of No Significant Impact."

4. Revised Chapter 4, “Preparing an Environmental Impact Statement: Process”:
  - a. Moved detailed discussion of acceptance review to Section 1.3.3.
  - b. Clarified information in Section 4.2.4, “Consultations and Cooperating Agencies.” General consultation information was consolidated in Section 1.4, “Consultations.”
  - c. Reorganized and updated Section 4.4, “Publishing the DEIS.”
  - d. Updated and clarified information in Sections 4.5, “Finalizing the EIS.”
5. Reorganized appendices including:
  - a. Environmental Justice Procedures (Appendix C) are included as “draft interim,” pending final Commission approval of a comprehensive environmental justice policy.
  - b. New Appendix D, “Consultation Procedures,” providing detailed procedures for consulting with the affected State, the U.S. Fish and Wildlife Service (Section 7 consultation), and the State Historic Preservation Officer (Section 106 consultation).
  - c. Revised Appendix E, “Example Letters and Documents,” to add new sample letters and documents.
