


The purpose of this contract modification is to extend the period of performance by three months to November 30, 2003, at no additional cost or obligation to the Government. Accordingly, the contract is modified as follows:

Under Section F.6, "DURATION OF CONTRACT PERIOD (MAR 1987)," the sentence is deleted in its entirety and replaced with the following sentence in lieu thereof:

"The contract commenced on June 24, 2002 and will expire on November 30, 2003."

All other terms and conditions of the contract remain unchanged.
