The purpose of this modification is to exercise Option Year Two in accordance with Section C.8, 52-217-9, entitled, "Option to Extend the Term of the Contract," and Section C.17, entitled, "Duration of Contract Period," thereby extending the contract period of performance through August 31, 2004. As a result of this action, the ceiling amount of the contract is hereby increased by \$637,300 from \$1252,100.00 to \$1,889,400.00.

Accordingly, the contract is hereby modified as follows:

1. Under Subsection C.16 Consideration and Obligation—Delivery Orders, the first sentence of paragraphs a and b are deleted in their entirety and substituted in lieu thereof the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services, ordered, delivered and accepted under this contract is \$1,889,400.00.

(b) The amount presently obligated with respect to this contract is \$1,129,584.00."

2. Subsection C.17, Duration of Contract Period, is deleted in its entirety and substituted in lieu thereof the following:

"C.17 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on September 1, 2001, and will expire on August 31, 2004. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18). There are no option periods remain under this contract."

There is no funding activity for the contract modification

All other terms and conditions under this contract remains unchanged.
