Waiver\_Purpose: Requestor will review records for information related to past and present NRC environmental review policies and procedures.

Waiver\_ExtentToExtractAnalyze: Requestor will analyze NRC policies and procedures contained in the records as thoroughly as possible. Records apply to past and current NRC actions and can be related to such actions.

Waiver\_SpecificActivityQuals: Research will be used to get a picture of past NRC policies as compared with current NRC policies re NEPA reviews. These are not technically complex records. Requestor is familiar with NRC policy and procedures to be able to understand the records requested and interpret their meaning and significance.

Waiver\_ImpactPublicUnderstanding: For some reason some of these records do not seem to have been made publicly available, so access to the records would increase the public's understanding. Records were listed in NUREG-1748.

Waiver\_NatureOfPublic: When these records are made publicly available on ADAMS they will be made available to everyone. Also, the public in southeastern Utah, a community that is impacted by NRC NEPA policy will also be informed.

Waiver\_MeansOfDissemination: Requestor has the ability to provide information to the interested persons in southeastern Utah. ADAMS will also help to disseminate information from the requested records.

Waiver\_FreeToPublicOrFee: No access fee will be charged for any of the information requestor gleans from the requested records and makes available to others.

Waiver\_PrivateCommericalInterest: Requestor has no private or commercial interest in the requested records, to the best of requestor's knowledge.
