
In the Reference letter, the NRC requested licensees to voluntarily submit a response concerning initial operator licensing examination needs, including an estimate of the number of applicants to be examined and intentions regarding the preparation of the examinations.

Attachments 1 through 10 provide the responses to RIS 2003-14 for the Exelon Generation Company, LLC (Exelon) and AmerGen Energy Company, LLC (AmerGen) plants identified above. The operator licensing examination information for each facility is provided on a separate NRC Form 536.

During Calendar Year CY 2005, a total of 6 candidates are expected to take the dual site Limited Senior Reactor Operator (LSRO) initial license examination as indicated in Attachment 6. The schedule for the indicated exam is as follows: the written exam and part of the operating exam will be given at Limerick Generating Station (LGS); the remainder of the operating exam will be completed at Peach bottom Atomic Power Station (PBAPS). Since the LSRO exam is a dual site exam that involves both LGS and PBAPS, rather than repeating the same information on both attachments, the exam scheduling information is provided on Attachment 6 for LGS only and Attachment 8 for PBAPS references Attachment 6.
