"NRC SENSITIVE UNCLASSIFIED SECURITY PROGRAM"

I reviewed the above subject, Management Directive (MD) 12.6. Its definition of "sensitive unclassified information" does not include foreign government information passed to NRC in confidence with the request that it be protected from the public. This category of information is also not covered in MD 12.2, "Classified Information Security Program."

Currently, sensitive, unclassified foreign government information passed to NRC in confidence is handled as proprietary information. Therefore, if this category of information is not addressed in another MD chapter, I recommend that it be addressed in MD 12.6, "NRC Sensitive Unclassified Security Program."
