To Counsel for the Parties in PFS:

To follow up as early as possible (without interfering with religious observances) on the events through yesterday (Thursday, October 2) projected in Mr. Turk's letter of September 25, the PFS Board wishes to hold another prehearing conference call next Tuesday, October 7, at 1:00 PM Eastern (11:00 AM Mountain) time. Those intending to participate in the call should respond (to all the recipients of this email) concerning your availability at that time; if unavailable, please suggest another time.

During the call, the Board wishes to hear the parties' latest thinking, consensus or otherwise, on the impact of the second round of RAls on the previously-adopted schedule. In that regard, the parties should be prepared to address the feasibility of (1) conducting certain scheduled activities concurrently rather than consecutively and (2) entering into stipulations that might obviate the need for the live testimony of particular witnesses.

The Board also wishes to discuss with the parties their preparation before the trial of a more detailed version of the "Proposed Key Determinations" that proved so helpful before, during and after the 2002 hearings. The parties' views as to the content of such a document will be welcome, all with an eye to enabling the Board to focus, shorten and expedite its eventual decision-writing tasks.
